

DO HEREBY RESOLVE:

WHEREAS, Section 81 of the The Indian Act provides that Council may pass bylaws for the following purposes:

- (1) The Council of a band may make by-laws not inconsistent With this Act or with any regulation made by the Governor in Council or the Minister, for any or all of the following purposes, namely,
 - (c) the observance of law and order;
 - (d) the prevention of disorderly conduct and nuisances
 - (q) with respect to any matter arising out of or ancillary to the exercise of powers under this section;
 - (r) the imposition on summary conviction of a fine not exceeding one thousand dollars or imprisonment for a term not exceeding thirty days, or both, for violation of a by-law made under this section.


WHEREVER Y RESOLVE:

- (2) Where any by-law of a band is contravened and a conviction entered, in addition to any other remedy and to any penalty imposed by the by-law, the court in which the conviction has been entered, and any court of competent jurisdiction thereafter, may make an order prohibiting the continuation or repetition of the offence by the person convicted.

WHEREAS, the incidence of noise in the Beardy's & Okemasis First Nation is such that Band Council deems it expedient that regulations be made restricting and abating the activities which give rise to unnecessary noise in the Beardy's & Okemasis First Nation; and

WHEREAS, the intent of this by-law is that all noise shall be reduced as far as possible compatible with the normal activities of urban life and that unnecessary noise be eliminated; and,

THEREFORE BE IT RESOLVED, that the Band Council of the Beardy's & Okemasis First Nation, on this day, pass approval The Noise Act to be effective as of May 29, 1998.
