Poplar Hill Band Council By-laws

95. An Indian who

- (A) has intoxicants in his possession,
- (B) is intoxicated, or
- (C) makes or manufactures intoxicants

on a reserve, is guilty of an offence and is liable, on summary conviction, to a fine of not less than ten dollars and not more than fifty dollars or, to imprisonment for a term not exceeding three months, or to both fine and imprisonment.

R.S., c. 149, s.94.

97. A person who is found

- (A) with intoxicants in his possession, or
- (B) intoxicated

on a reserve is guilty of an offence and is liable, on summary conviction, to a fine of not less than ten dollars and not more than fifty dollars or, to imprisonment for a term not exceeding three months, or to both a fine and imprisonment. R.S., c. 149, s.96.

- -No person is allowed to drive a ski-doo or boat when intoxicated.
- -No person is allowed to drive a ski-doo or boat after 9 PM without written consent from the chief and council.
- -No child is allowed to walk around outside after 9 PM. unless accompanied by his parents or an adult.
- -The police are permitted to use a search warrant.
- -No person may buy or sell without the written consent of the chief and council.
- -A minister is allowed to perform his duties.
