BY-LAW #9

TITLE

A By-law to provide traffic regulations on the Oneida Reserve.

PREAMBLE

Whereas it is deemed advisable that traffic regulations are established and enforced on the Oneida Reserve pursuant to the authority of Section 81 (B) of the Indian Act and in addition to the Provincial traffic laws already in effect.

ENACTMENTS

Now therefore the Council of the Oneida Band of Indians hereby enacts as follows:

#1 A by-law to provide for the regulation of speed on Oneida Reserve #41 pursuant to sub. sec. (b) of Sec. 81 of the Indian Act.

- (a) The maximum speed limit shall be 40 M.P.H. on Oneida Reserve.
- (b) Restricted zones shall be 15 M.P.H.
- (c) Any person who violates any of the provisions of this By-law shall be guilty of an offense and shall be liable on summary conviction to a fine of twelve dollars for the first ten miles over the speed limit and two dollars per each additional mile over the ten miles, or imprisonment for a term not to exceed ten days or both fine and imprisonment.

#2 A by-law to provide for the regulations of parking in the right-of-way of Oneida Reserve #41 in the Province of Ontario.

- (a) No person shall park a vehicle in front of any driveway.
- (b) No double parking as to obstruct traffic.
- (c) No unnecessary parking on a hill.
- (d) Loitering parking shall be prohibited.
- (a) Any person who violates any provisions of this by-law shall be guilty of an offense and shall be liable, on summary conviction to a fine not exceeding ten dollars or imprisonment to a term not exceeding seven days or both fine and imprisonment.

 $\vec{+}3$ A by-law to provide for the regulations of stop signs so erected at intersections as follows:

Intersections Conc. "C" road to Elgin & Middlesex County Line. 4-way stop signs at Conc. "C" and 21st sideroad going N. E. S. & W. Conc. "C" road and 18th sideroad going N. & S. Kahizie road and 18th sideroad going S. 1st Conc. Delaware going N. & S. at 18th sideroad. New Hall Road and 18th going N. & S. Oneida Village Road to New Hall Road going E. 21st to New Hall Road going W. 21st to New Hall Road going E. 21st to Oneida Road going W. New Hall Road to Elgin & Middlesex County Line going S. Intersection Elgin & Middlesex County Line & Oneida Road. Signs installed by Elgin County, Dennison Cornelius Road to 18th going S. At intersection 18th and Oneida Road going S. & E. 21st sideroad to 1st Conc. Delaware going E.

(a) Any person who violates any provisions of section 81 sub. "B" of R.S.C. 1952 C 149 of this by-law or failing to stop at a stop sign shall be guilty of an offense and shall be liable on a summary conviction to a fine not exceeding \$22.00 or imprisonment not exceeding five days or to both fine and imprisonment.

#4 No person shall remove, deface, obliterate, alter or attempt to remove, deface, obliterate or alter, or in any manner interfere with any traffic sign lawfully placed on a road.

- (a) Any person who violates any provisions of this by-law shall be guilty of an offense and shall be liable upon summary conviction to a fine not exceeding \$50.00 (fifty dollars) or imprisonment not exceeding thirty days or both fine and imprisonment. Made under this section 1951 chapter 29, section 81, subsection "B".
- $\frac{\#5}{\text{Reserve}}$ A by-law to provide for unsafe or dangerous vehicles on Oneida
- (a) No person shall drive or operate or permit the driving or operation of a vehicle which is mechanically unfit.
- (b) Dirty taillights, headlamps or licence plate light, muddy or obstructed windshields.
- (c) A slow moving vehicle shall have the provincial "slow moving vehicle sign".
- (d) A dangerous or overhanging load of 5' beyond the back of the vehicle shall have a red marker or red lights for nights.
- (e) Any person who violates any provisions of Section 81 sub B of R.S.C. 1952 C 149 of this by-law shall be guilty of an offense and shall be liable upon a summary conviction to a fine of not less than \$10.00 to a maximum of \$100.00 or imprisonment not exceeding 30 days or both fine and imprisonment.
- #6 A by-law to provide for the regulation of traffic signs so erected on Oneida roads as follows:

Hidden Intersection
Curve Signs
Dead-end Signs
No Thru-way
Steep Hill Signs

Right and Left Turns Speed Signs Parking Signs Loitering Signs No Dumping Signs No Loitering Signs

The penalties for this by-law shall apply under by-law #4.

- The driver of any vehicle shall bring such vehicle to a full stop when ordered by an Indian Constable authorized by Oneida Band Council.
- (a) Failing to Stop
- (b) Failing to show operators
- (c) Failing to show chauffeurs
- (d) Failing to show ownership
- (e) Failing to show proof of insurance
- (f) Any person who violates any provisions of this by-law shall be guilty of an offense and shall be liable upon summary conviction to a fine not exceeding \$23.00 or imprisonment not exceeding ten days or to both fine and imprisonment. Made under the Indian Act, Sec. 81 sub. sec. "B".
- #8 Bus Transportation of School Children.
- (a) When a vehicle being driven on any part of the Oneida Indian S:ttlement is overtaking or meeting a school bus, engaged in the transporting of children, which is stopped with flashing lights, to take on or discharge children whether the vehicles are travelling in the same direction or not, the driver of such motor vehicle shall come to a full stop at least ten feet from the rear or front of such school bus, and shall not pass or drive beyond any part of such bus, until all children have boarded or have left and reached the side of the road and such bus has been set into motion.
- (b) Any person who violates any provisions of this by-law, made under Section 81, sub. sec. B of the Indian Act, shall be guilty of an offense and shall be liable on a summary conviction to a fine of not less than \$25.00 and not more than \$50.00 or to imprisonment of 15 days or to both.

- #9 Indictable Offenses derived from Oneida Traffic Laws. Provincial Law shall prevail.
- (a) Such examples would be Hit & Run, Motor Manslaughter, Injuries resulting from accident, Auto Theft, etc.
- (b) Any traffic offenses not mentioned in Oneida by-laws then Provincial Law will be enforced.
