 Therefore be it resolve, on September 17, 1979, the following by-law comes into effect as of this date.

No person or persons will be allowed to bring in, or have in their possession any intoxicants.  
 Any Band member not observing this by-law will be subject to immediate dismissal of employment and will not be eligible for welfare asisstance.  
 Immediate action will be taken to inform legal authorities for non-members of the Band not observing this by-law.

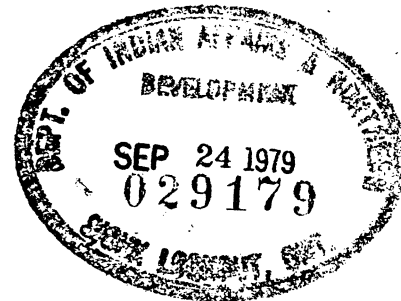
