DO HEREBY RESOLVE: But Law Me. !

BEING A BY-LAW TO AUTHORIZE THE CARRYING ON OF A COMMUNITY PROGRAM OF RECREATION WITHIN THE MEANING OF THE REGULATIONS UNDER THE DEPARTMENT OF EDUCATION ACT.

- 1. THE COUNCIL OF THE BAND EMACTS AS FOLLOWS:
 - (a) PURSUANT TO REGULATION 19/66 MADE UNDER THE DEFARTMENT OF EDUCATION ACT, A COMMUNITY PROGRAM OF REGREATION IS HEREBY ESTABLISHED FOR THE RESIDENTS OF THE RESERVE.
 - (b) THE SAID COLLUNITY PROGRAM OF RECREATION SHALL BE DIRECTED, MANAGED AND CONTROLLED ON BEHALF OF THE COUNCIL BY A COLMITTEE KNOWN AS THE RAINY RIVER RECREATION COMMITTEE.
- 2. THE COMMITTEL SHALL BE APPOINTED FROM TIME TO TIME BY THE COUNCIL AS FOLLOWS:
