DO HEREBY RESOLVE:

BEING A BY-LAW TO AUTHORIZE THE CARRYING ON OF A COMMUNITY PROGRAM OF RECREATION WITHIN THE MEANING OF THE REGULATIONS UNDER THE DEPARTMENT OF EDUCATION ACT.

1. THAT COUNCIL OF THE BAND ENACTS AS FOLLOWS:

- (a) PURSUANT TO REGULATION 19/66 MADE UNDER THE DEPARTMENT OF EDUCATION ACT, A COMMUNITY PROGRAM OF RECREATION IS HEREBY ESTABLISHED FOR THE RESIDENTS OF THE RESERVE.
- (b) THE SAID COMMUNITY PROGRAM OF RECREATION SHALL BE DIRECTED, MANAGED AND CONTROLLED ON BEHALF OF THE COUNCIL BY A COMMITTEE KNOWN AS THE NORTHWEST BAY RECREATION COMMITTEE.

2. THE COMMITTEE SHALL BE APPOINTED FROM TIME TO TIME BY THE COUNCIL AS FOLLOWS:
