
By-Law No. 2

- (1) This By-Law may be cited as "The Curfew By-Law".
- (2) This By-Law is made pursuant to paragraphs (c) (d) (q) and (r) of seciton 81 of the Indian Act.
- (3) The purpose to this By-law is to provide for the regulation of the activities of boys and girls upon the Reserve or any part or parts thereof of the Band, under 17 years of age in order to prevent misconduct and nuisance.
- (4) The Washagamis Bay Band Council hereby enacts the following as a By-law.
 - (a) No boy or girl on a Reserve of Washagamis Bay under 17 years of age shall loiter in any place within the said Indian Reserve after 11 o'clock in the evening until 6 o'clock in the morning.
 - (b) No boy or girl on the Reserve of Washagamis Bay Band under 17 years of age shall in any place of amusement, vacant buildings, streets, lanes, by-ways or roads within the said reserves, or shall be in the course of returning from any place of entertainment off the said reserve after 11 o'clock pm unless accompanied by his/her parent or an adult appointed by a parent to accompany such child, or unless authorized for a specific purpose by the parent to return to the Reserve beyond 11 o'clock p.m.



- (d) A parent who permits his child to violate paragraph (a) or (b) shall be guilty of an offence and shall be liable on a Summary Conviction to a fine not exceeding \$100 or imprisonment for a term not exceeding 30 days, or both fine and imprisonment.
- (5) This By-Law was approved and passed at a Emergency General Band Meeting on July 24, 1984.
