WASHAGAMIS BXY BAND OF INDIANS.

By-law number: -1 - ...

A by-law to regulate traffic.

- 1. WHEREAS Clause b of Section 81 of The Indian Act empowers the Council of Washagamis Bay Band to make by-laws for the regulation of traffic.
- 2. AND WHEREAS Clause r of the said Section empowers the Council of the Band to make by-laws imposing penalties.
- 3. AND WHEREAS it is deemed expedient to regulate traffic within Rat Portage Indian Reserve 38A, wherein the Council of Washagamis Bay Band has authority for the purpose hereafter set forth.
- 4. AND WHEREAS the Council of Washagamis Bay Band, for the safety and welfare of the inhabitants of Rat Portage Indian Reserve 38A, have resolved as hereafter set forth.
- 5. NOW THEREFORE BE IT ENACTED, AND IT IS HEREBY ENACTED, by the Council of Washagamis Bay Band as follows:
- 6. In this By-law:
 - (a) "Council" means the Council of Washagamis Bay Band as from time to time constituted.
 - (b) "Reserve" means Rat Portage Indian Reserve 38A.

- (c) "road" includes any roadway, driveway, street, lane and other place open for the passage of vehicles.
- (d) "sign" includes every sign, warning, marking and device for the guidance and direction of persons operating any vehicle on the Reserve.
- (e) "vehicle" means any wagon, card, motor car, motor truck, trailer, motor cycle, traction engine, tractor, road-making machine and any other conveyance which is driven, propelled or drawn by any kind of power.
- 7. No vehicle shall be operated on any part of the Reserve except the roads.
- 8. No vehicle shall be operated on the Reserve at a speed in excess of forty (40) kilometers per hour.
- 9. No vehicle shall be operated on the Reserve in an umsafe or careless manner having regard to the safety and welfare of the inhabitants of the Reserve, others using the roads, and the operator and passangers of and in each vehicle.
- 10. No vehicle shall be operated on the Reserve which is unsafe having regard to the safety and welfare of the inhabitants of the Reserve, others using the roads, and the operator and passangers of and in each vehicle.
- 11. No person shall park, station or leave any vehicle on any

road unless permission to do so is evidenced by signs placed pursuant to Band Council Resolution.

- 12. The Council may by Band Council Resolution direct the placing of any sign or signs which the Council may from time to time for the safety and wellfare of the inhabitants of the Reserve deem to be necessary or desirable.
- 13. The Council may by Band Council Resolution at any time and from time to time close any road or any part of any road and at any time and from time to time re-open the same.
- 14. Every person shall obey each and every sign at any time and from time to time placed on the Reserve or any road and each and every direction and order given for the safety and wellfare and wellfare of the inhabitants of the Reserve, others using the roads, and the operator and passangers of and in each vehicle.
- 15. No person shall interfere with or attempt to interfere with the placing and maintanence of any sign and no person shall remove, deface, obliterate, all ter or attempt to remove, deface, obliterate or alter or in any manner interfere with any sign.
- 16. Every person who viddates any provision of this By-law shall be guilty of an offence and shall on summary conviction be liable to a fine not exceeding one hundred dollars (\$100.00)
