DO HEREBY RESOLVE:

Moravian of The Thames Indian Band By Law No. 4

Whereas by virtue of Section 80 of the Indian Act, the Council of the Moravian of the Thames Indian Band is empowered to make By Laws with respect to the observance of law and order and the prevention of disorderly conduct and nuisances

Now Therefore Be It Enacted as a By Law of the Council of the Moravian of the Thames Indian Band as follows:

- That no alcoholic beverages will be allowed on the recreation grounds or in the recreation hall; nor will any drinking of alcoholic beverages be allowed on these premises situated on Lot 75, Parcel B.
- That no person is allowed on the recreation grounds Lot 75, Parcel B before 4:00 P.M. local time on Sundays unless accompanied by one of the following authorized officials:
  - President Recreation Committee a)
  - b) Chairman - Recreation Committee
  - Secretary Recreation Committee c)
  - Chief Moravian of the Thames Band d)
  - Councillor Moravian of the Thames Band e)
- That the lights at the ball grounds, Lot 75, Parcel B be turned off at 11:00 P.M. local time.
- That record dances held on the recreation grounds or in the recreation hall located on Lot 75, Parcel B be closed at 11:30 P.M. local time.
