- That NOAH WINTER is hereby appointed Lottery Licencing Officer for the Reserve of Kingfisher Lake.
- That the said appointee NOAH WINTER shall hold office during the pleasure of the Council and shall exercise all the authority, powers and rights and shall perform all the duties and obligations which by Statute or by-laws are or may be conferred or imposed upon the Lottery Licencing Officer and any other duties that may be imposed by Council.
