DO HEREBY RESOLVE: **THAT this By-law be known as By-law #3**  
**WHEREAS it is desirable that the laying out and supervision of all work and expenditure upon improvement and maintenance of roads within the exclusive jurisdiction of this Council should be under the supervision of a Road Superintendent, acting under its direction.**  
**AND WHEREAS it is the desire of this Council to take advantage of The Highway Improvement Act and to receive the Government grant as provided in the said Act.**  
**BE IT THEREFORE ENACTED by the Council of Wikwemikong Indian Reserve—and it is hereby enacted.**

1. That.....Andrew Manitowabi.....Wikwemikong, Ontario..... is appointed Road Superintendent in the said..Reserve.. to act as aforesaid in accordance with the provisions of the said Act from the..10th..day of..February..1969..and during the pleasure of the said Council.
2. That the Road Superintendent shall be paid at the rate of ..\$2.55..per..hour..for such time as he may be so employed.
3. THAT it shall be the duty of the superintendent to lay out and supervise all work and expenditure on roads within the exclusive jurisdiction of this Band Council in accordance with the provisions of the Highway Improvement Act.
4. THAT all by-laws or parts thereof and all and any resolutions of said Council contrary hereto or inconsistent herewith, be and the same are hereby repealed.
5. THAT two certified copies of this by-law be forwarded by the clerk without delay to the district office of the Municipal Roads Branch, Department of Highways, Ontario.
6. THAT this by-law shall not come into force until approved by the Minister of Highways, as provided in the Highway Improvement Act.
