Appendix A

Smoking By-law # 2006.1 addendum to include outdoor properties, parks and playgrounds

Whereas, the Chief and Council of Whitefish River First Nation recognizes the alarming rates of smoking that are affecting all stages of life in the community of Whitefish River Nation. In addition, it has been determined that second-hand smoke is a serious health hazard; and

Whereas, the tobacco misuse among the younger population is a concern for the health of our future children/youth. In addition, we recognize that there are health concerns among the adult population and the overall impact of smoking related illnesses. Smoking continues to be one of the major preventable causes of death and illnesses among our nation.

Whereas, pursuant to section 81.(1)(a) of the *Indian Act*, the council of a band may pass by-laws for band purposes providing for the health of residents on a reserve; and

Whereas, pursuant to section 81.(1)(q) of the *Indian Act*, the council of a band may pass by-laws for band purposes with respect to any matter arising out of or ancillary to the exercise of powers under this section; and

Therefore, the Council of the Whitefish River First Nation Band hereby makes the following Addendum to the Smoking By-law.

To include:

Whereas, the amended smoking by-law will now include: Outdoor Smoke Free Spaces playground area (s) and all soccer and ball fields; Whitefish River First Nation Track and Field; basketball court, soccer field and ball field court (s) and the Raven Youth Centre and the Pow Wow Grounds located at Sunshine Alley

SHORT TITLE

1. This by-law may be cited as the "Whitefish River First Nation Smoking By-law;

PART I – PROHIBITIONS

3. The following are designated public places for the purpose of this amended by-law will now include:

- Outdoor Rink
- Maple Heights Playground on Ogimaa Wabekik Road
- Soccer Field and Track Field on Ogimaa Wabekik Road
- Basketball Court on Ogimaa Wabekik Road
- Raven Youth Center on Bay of Islands Road
- Playground at Ogimaa Wabekik Road
- Pow Wow grounds located at Sunshine Alley
- Seven Fires Youth and Elders Centre located on 46 Bay of Islands Road
- Administration Building located on 17B Rainbow Ridge Road
- Health Centre located on 17 Rainbow Ridge Road

SIGNAGE:

8. Where, under any sections of this by-law, a sign is to be in accordance with this subsection, such sign shall;

- (a) Carry the text, "NO SMOKING", in capital letters;
- (b) Consist of two (2) contrasting colors, or if lettering is to be applied directly to a surface or to be mounted on a clear panel, the lettering shall contrast to the background color;
- (c) Have letter heights that render the sign clearly visible and readable, based on the maximum viewing distance (in direct line of sight) in the area where smoking is prohibited.
- (d) Any such symbol shall be on a white background with the circle and the interdictory stroke in red, with a cigarette, letters and figures in black, and provided that the diameter of the circle is at least fifteen (15) cm.
- (e) Signage indicating that you must be 9 meters away from the buildings.
- (f) Signage indicating a nine- meter radius within the specified area of outdoor smoke free spaces
- (g) Signage to include children playing with any such symbol shall be on a white background with the circle and the interdictory stroke in red, with a cigarette, letters and figures in black, and provided that the diameter of the circle is at least fifteen (15) cm.

- (i) Signage for punch rivets to include a 6" x 6" vinyl decals for Smoke Free Bylaw with any such symbol shall be on a white background with the circle and the interdictory stroke in red, with a cigarette, letters and figures in black, and provided that the diameter of the circle is at least fifteen (15) cm.








