WHITEFISH RIVER INDIAN RESERVE #4

BY-LAW NO. 2

SPECIAL BAND CONSTABLES

The Band Council of Whitefish River Indian Reserve #4 resolves to make the following rules and conditions applied to persons employed by this Band as Special Constables.

- (a) THE MEMBER SHALL enforce all Federal Law, Government of Ontario Law and By-laws made by the Whitefish River Band Council #4 on Whitefish River Indian Reserve #4.
- (b) THE MEMBER SHALL protect property, preserve the peace and apprehend Offenders on Whitefish River Indian Reserve #4.
- (c) THE MEMBER SHALL attend courses at the places and times determined by the Indian Policing Branch in conjunction with officials of the O.P.P. College, Ontario Police College and the local O.P.P. Liaison Officer.
- (d) THE MEMBER SHALL ensure proper care of all items of uniform and equipment and report any damage to his O.P.P. Liaison, Officer.
- (e) THE MEMBER SHALL, upon proof of his competence in the use of a firearm and the issuance of such firearm, carry such firearm only during his duties as a Special Constable.
 - 1. The firearm shall be carried in a holster with a full flap.
 - 2. The member shall not draw nor display his firearm except in the legal performance of his duties.
 - 3. The member shall insure safe storage of the firearm at all times.
- (f) THE MEMBER SHALL maintain his hair cut to taper to no closer than one (1) inch above the shirt collar and sideburns shall not extend beyond the lower portion of the auditory opening of the ear and shall not exceed one (1) inch in width.
- (g) THE MEMBER SHALL wear the items of uniform and equipment which have been issued to him.

- (h) THE MEMBER SHALL not enter upon a premises licensed to sell alcoholic beverages nor shall he consume alcoholic beverages while in uniform except in the legal performance of his duties.
- (i) THE MEMBER SHALL seek advice from and be supervised by a member of the Ontario Provincial Police Force.
- (j) THE MEMBER SHALL not conduct himself in a manner that may bring discredit to himself, his fellow officers or other members of his Band.
- (k) THE MEMBER SHALL be subject to all laws as they apply to any other citizen as well as the aforementioned by-laws.
- (1) Any violation of the aforementioned by-laws shall be brought to the attention of the Band Chief and his Council who shall review the member's performance.
- (m) The Commissioner of the Ontario Provincial Police may rescind the Special Constable's authority for reasonable cause.
