Band shall invite or 2. accompany any person who is not a member of the above mentioned the purpose of trapping, fishing or hunting unless that person has first obtained a written permit to so do from the person authorized by the Council to grant such permission. FISHING Permits may be obtained only on production of a valid and subsisting 3. Ontario... Provincial License to fish in provincial waters contiguous to the reserve. 4. Such permit shall authorize the permittee to fish by angling only and may be subject to a fee established from time to time by resolution of the Council of the Band. No person under authority of such permit, shall fish for, take or 5. attempt to take in one day, more than ten large or ten small mouth bass or any (a) combination of ten thereof, without respect to size; more than three maskinonge or thirty lbs, plus one fish; (b) more than ten pickerel (dore) or twenty lbs. plus one fish; more than six pike or thirty pounds plus one fish; (d) more than five lake trout or thirty pounds plus one fish; (e) more than twenty speckled trout or ten pounds which ever (i)is the lesser; more than one sturgeon; (g) more than twenty crappies, bull heads, suckers; (h)

more than twenty fish in the aggregate of all species

sted above.

- 6. No person shall retain, keep out of water or have in his possession:
  - (a) any maskinonge of a total length less than 28 inches
  - (b) any pickerel (dore) of a total length less than 15 inches
  - (c) any pike of a total length less than 18 inches
  - (d) any lake trout of a total length less than 15 inches
  - (e) any speckied trout of a total length less than 7 inches
  - (f) any sturgeon other than the first sturgeon taken or caught regardless of size.
- 7. No person shall retain, keep out of water or have in his possession more than one day's limit as set out in Sec. 5 and 6 of this by -law.

## HUNTING

## GUIDES

- 12. All band members before being permitted to act as guides must register with the council of the band, who will issue free of charge to each member who registers a licence to guide on the reserve.
- 13. Every guide licensed under the preceding section is required to abide by any rules and regulations set down by the Council for the instruction of guides and failure to do so will result in the revoking of the license to guide.

## ENFORCEMENT

14. The Chief and Councillors of the Band, Indian constables and any other person or persons named by the Council shall be ex-officio officers for the entrof this by-law.

- Any officer for the enforcement of this by-law shall forthwith seize all game or fish protected by this by-law, which
  - (a) is found by him in possession of any person, other than a member of the Band, who is not in possession of a permit under Sec. 3 or 9 of this by-law;
  - (b) appears to have been taken by some unlawful means; and shall bring such game or fish before a police magistrate.

    stipendiary magistrate or person appointed by the Governor in

    Council to be a justice of the peace for offences under the Indian Act.
- 16. Where a person is convicted of an offence under this by-law, the convicting court or judge may order that the game, fish, in addition to any penalty imposed, are forfeited to Her Majesty for the benefit of the band provided, however, that the meat or fish so forfeited shall be delivered to a charitable institution designated by the Council.

## PENALTIES

17. Any person who violates any of the provisions of this by-law shall on summary conviction be liable to a fine not exceeding one hundred dollars or imprisonment for a term not exceeding thirty days or both fine and imprisonment.
