BY-LAW NO. 201-1996-01

## DISORDERLY CONDUCT

Being a By-law pursuant to sub-section 81 (1) (d) of the Indian Act, R.S.C. 1985 c. 1-5, to regulate the conduct of person in premises belonging to the Serpent River First Nation.

## Definitions: 1. In this by-law,

#### -Lands reserved for the Serpent niver First Maties

a) "Lands reserved for the Serpent River First Nation" and "reserve" mean all lands which are from time to time held in trust for the use and benefit of the Serpent River First Nation;

#### "Sespent River First Mation

b) "Serpent River First Nation" means the Serpent River Band of Ojibway, an Indian Band pursuant to the Indian Act;

## Indian Act definitions

c) Words or phrases used by not expressly defined in this by-law which are expressly defined in the Indian Act, R.S.C. 1985 c. I-5, as amended from time to time, shall have the meaning ascribed to them in that Act.

#### Prohibition against disorderly conduct.

 No person shall conduct himself or herself in a disorderly manner in premises or on common lands belonging to or reserved for the Serpent River First Nation.

### Expulsion or exclusion

3. The Band Manager, custodian, or other person in care and control of any premises or common lands belonging to or reserved for the Serpent River First Nation, may expel or exclude from those premises or common lands any person causing a disturbance or conducting himself or herself in a disorderly manner, and may obtain the assistance of the Ontario Provincial Police to remove the person from those premises or common lands.

# 24 hour rule

- 4. A person expelled or excluded from premises or common lands pursuant to this By-law shall not return to those premises or lands for a period of 24 hours, unless earlier written authorization to re-enter is obtained from the Band Manager or from Chief and Council.
- 5. A person who contravenes this By-law is guilty of an offence punishable on summary conviction and shall be liable on conviction to a fine not exceeding ONE THOUSAND (\$1000.00) DOLLARS or imprisonment for a term not exceeding thirty (30) days, or both fine and imprisonment.

ENACTED as a by-law of the Serpent River First Nation by Band Council Resolution # 96-028 passed at the Serpent River Reserve No. 7 this 21st day of May, 1996.
