DO HEREBY RESOLVE:

THAT THE FOLLOWING LY-LAW PURBUANT TO PARAGRAPH (G) OF SECTION EO OF THE INDIAN ACT BE EMACTED TO BE EFFECTIVE FUNDY BAYS FROM THIS DATE, FEBRUARY 19, 1969, In accordance with paragraph (2) of Section C1 of the Indian act.

A LY-LAW TO PROVIDE ZONING REGULATIONS APPLYING TO TWO PORTIONS OF AGENCY RESERVE NO. 1:

- (A) THAT THE LAND LEASED TO THE RAINY LAKE GOLF AND COUNTRY CLUB UNDER LEASE NUMBER: 228 AND 232 BE ZOMED AD COMERCIAL-RECREATIONAL FOR THE LALARCE OF THE PRESENT LEASE PERIOD ON SCONER IF THE LEASE IS TEXTIGATED.
- (b) THAT THE LAND KNOWN ALL PITHERS POINT PARK AND LEASED TO THE FORT
 FRANCES PARKS BOARD UNDER LEASE NUMBER 231 BE ZONED AS COMMERCIAL—
 RECREATIONAL FOR THE BALANCE OF THE PRESENT LEASE PERIOD OR SOCNER
 IF THE TEASE TO TERMINATED.
