THAT THE FOLLOWING BY-LAW PURSUANT TO PARAGRAPH (C) OF SECTION 80 OF THE INDIAN ACT BE ENACTED TO BE EFFECTIVE FORTY DAYS FROM THIS DATE, FEBRUARY 19, 1969, IN ACCORDANCE WITH PARAGRAPH (2) OF SECTION 81 OF THE INDIAN ACT.

BY-LAW NO. 2 (1)

A BY-LAW TO PROVIDE ZONING REGULATIONS APPLYING TO TWO PORTIONS OF AGENCY RESERVE NO. 1:

- (A) THAT THE LAND LEASED TO THE RAINY LAKE GOLF AND COUNTRY CLUB UNDER LEASE NUMBERS 228 AND 232 BE ZONED AS COMMERCIAL-RECREATIONAL FOR THE BALANCE OF THE PRESENT LEASE PERIOD OR SOONER IF THE LEASE IS TERMINATED.
- (B) THAT THE LAND KNOWN AS PITHERS POINT PARK AND LEASED TO THE FORT FRANCES PARKS BOARD UNDER LEASE NUMBER 231 BE ZONED AS COMMERCIAL-RECREATIONAL FOR THE BALANCE OF THE PRESENT LEASE PERIOD OR SOONER IF THE LEASE IS TERMINATED.

BY-LAW NO. 3 /
