DO HEREBY RESOLVE: By-law No. 7 pursuant to paragraph (c), paragraph (d), and paragraph (r) of Section 80 of the Indian Act.  
Motion No. 3.

Moved by Roy Wesley, seconded by Robert Nashkewa that we pass a by-law to provide for the observance of law and order and for the prevention of disorderly conduct and nuisance on the Saugeen Indian Reserve.

- In this by-law, "public place" includes any place to which the public have access as of right or by invitation express or implied.
- No person shall cause a disturbance in or near a public place
  - by fighting, screaming, shouting, swearing, singing, or using insulting or obscene language;
  - by being drunk, or
  - by impeding or molesting other persons.
- No person shall openly expose or exhibit an indecent exhibition in a public place or commit any act in a public place which offends against public decency or order.
- No person shall loiter in a public place or in any way obstruct persons who are there.
- No person shall disturb the peace and quiet of the occupants of a dwelling house by discharging fire-arms, or by other disorderly conduct in a public place, or dwelling house.
- No person shall without lawful excuse, the proof of which lies upon him, prowl or loiter by day or by night upon the property of another person near a dwelling house situated on that property without the owner's permission either express or implied.
- Any person who violates any provisions of this by-law shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding \$ 100.00 or imprisonment for a term not exceeding 30 days or both fine and imprisonment. Carried.
