











- I - All stray dogs are to be claimed and taken care of by the rightful owners; either by
    - A) i) tying up the dog in question.
    - ii) making arrangements to have the dog confined, or
    - iii) give direction to the Chief and Council to terminate the dog(s).
  - B) Failure to abide by these condition will result in the termination of the stray dog(s).
- II - All dog owners are to ensure that their dogs are under their control at all times.
- A) i) all dogs owners are to be within the site and hearing distance of their dogs at all times.
  - ii) should a dog occasionally stray away from the owner, then the owner will be responsible to recapture that dog and to ensure that it does not happen again.
  - B) Should the dog owner fail to control his/her dog, then that owner is to tie up that dog to prevent the dog from running loose.


