 - ii) repeated failure will result in a fine not exceeding \$50.00.
 - iii) continual failure to control the dog will result in the termination of that dog.

- i) bite or nip at people
- ii) that chase people that:
 - run/jog
 - ride bicycles
 - ride snowmobiles
 - motor cycles
 - walk

iii) snarl at and are about to bite people

A) i) It is an offence for a person who transports a dog on the back of his/her pick-up where it will rial up other dogs and/or jeopardizes the safety of innocent by standers.
