DO HEREBY RESOLVE:
DÉCIDE, PAR LES PRÉSENTES: Intoxication By-law

Whereas the Grassy Narrows Chief and Council would like to re-instate and re-affirm the Intoxication By-law passed honour about January 8, 1986 for the Grassy Narrows Reserve;

Whereas the Grassy Narrows Band has the authority to control the sale and possession of intoxicants and the conduct of intoxicated persons for the better preservation of the safety and security of citizens and residents of the Grassy Narrows Reserve.

Whereas a majority of the electors of the Band who attended a special meeting of the Grassy Narrows Band on January 10th, 1986 called by the Council of the Grassy Narrows Band on January 8, 1986 for the purpose of considering the contents of this by-law, consented to the contents of this by-law.

Definitions

- In this By-law "Intoxicants" include, alcoholic, spirits, vinous, fermented malt or other intoxicating liquor or combination of liquors and mixed liquor a part of which is spiritous, vinous, fermented or otherwise intoxicating and all drinks or drinkable liquids and all preparations or mixtures capable of human consumption that are intoxicating or intended to be used as an intoxicant.
- "Intoxicated" for the purpose of this by-law has it's ordinary meaning but, in addition thereto any person who being 21 years of age or less and have consumed alcohol shall be deemed to be intoxicated.
- Everyone who sells, barter, supplies, gives, manufactures or transports intoxicants on the reserve of the Grassy Narrows Band is guilty of an offence punishable of summary conviction.
- Everyone who is intoxicated on the reserve of the Grassy Narrows Band is guilty of an offence punishable of summary conviction.
- Everyone who is found in possession of intoxicants on the reserve of the Grassy Narrows Band is guilty of an offence punishable on summary conviction.



Exception Clauses
