 - (a) "At Large" shall mean any dog found not under the immediate control of it's owner, or competent or responsible person, or not on the owner's property or apparently unattended.

- (4) Every dog owner shall within 30 days of the passing of this by-law, apply at the Cape Croker Administration Office/Cape Croker Police for the purpose of obtaining a Dog License and the Burden of Proof shall be on the owner that they have such a license.
- (5) Every dog over the age of 12 weeks shall be licensed and the owner shall keep the dog tag securely fixed on the dog at all times.
- (a) Each dog, male shall be licensed for a fee of Ten Dollars
 (\$10.00) to cover the period of one calendar year or a portion thereof.
 - (b) A female spayed dog licence fee shall be a sum of ten dollars (\$10.00) per year.
 - (c) A female dog not spayed, the licence fee shall be fifteen dollars (\$15.00) for the first female and each additional female dog not spayed, the licence fee shall be twentyfive dollars (\$25.00).
