WESTBANK BAND OF INDIANS

BY-LAW NUMBER 1986-01

being a By-Law to amend the penalty provisions of other Westbank Indian Band By-Laws

WHEREAS Section 81(r) of the <u>Indian Act</u> has been amended to provide for the imposition of greater penalties upon conviction for violation of a By-Law made under Section 81 of the Indian Act;

AND WHEREAS the penalty provisions of Westbank Indian By-Laws currently in force are inadequate to ensure compliance with such By-Laws;

NOW THEREFORE the Council of the Westbank Indian Band in open meeting assembled enacts as follows:

1. SHORT TITLE:

This By-law may be cited for all purposes as the "Penalty Provisions Amendments By-Law, 1986-01".

2. PENALTY PROVISIONS:

The penalties provided for in the Westbank Indian Band By-Laws as listed in Schedule "A" to this By-Law, are hereby increased to provide for a fine not exceeding ONE THOUSAND (\$1,000.00) DOLLARS or imprisonment for a term not exceeding THIRTY (30) DAYS, or both, and the Westbank Indian Band By-Laws listed in Schedule "A" to this By-Law are amended accordingly.

The following provisions of the Westbank Indian By-Laws are amended as per Section 2 of Westbank Indian Band By-Laws Number 1986-01:

Section (f) of By-Law Number 1: A By-Law to provide for the disposal of garbage and waste on Westbank Reserve Number 9.

Section (h) of By-Law Number 2: A By-Law to provide for the erection and control of toilets or privies on the Westbank Reserve Number 9.

Section (e) of By-Law Number 3: A By-Law to provide for the regulation of the use of public wells, cisterns, reservoirs, and other water supplies.

Section (c) of By-Law Number 4: A By-Law to provide for the distruction and control of noxious weeds in Westbank Reserve Number 9.

Section 4(b) of By-Law Number 1979-2: Official Community Plan.

Section 18 of By-Law Number 1979-03: Water Works Regulations.

Section 11 of By-Law Number 1979-07: A By-Law to regulate the discharge of fire-arms.

Section 15.17 of By-Law Number 1979-08: A By-Law to regulate the construction, repair, demolition or removal of buildings.

Section 6 of By-Law Number 1979-14: A By-Law to regulate unsightly premises.

Section 14 of By-Law Number 1979-15: A By-Law to provide for the form, fee, and procedure for the issuance of development permits.

Section 39 of By-Law Number 1979-16: A By-Law to regulate traffic and the use of highways.

Section 15(3)(i) of By-Law Number 1980-02: A By-Law to provide for the raising of money by the licensing of businesses, callings, trades and occupations.

Section 14 of By-Law Number 1981-01: A Bylaw to provide for the taxation, control and destruction of dogs and other animals.

Section 6 of By-Law Number 1984-08: A By-Law to provide for the regulation of conduct at meetings of the Westbank Band of Indians.
