AND W IEREAS the Council of the BEAUSOLEIL FIRST NATION did enact certain by-laws in accordance with aforesaid sections of the *Indian Act*, R.S.C. 1985, c.I-5;

NOW THEREFORE the Council of the BEAUSOLEII. FIRST NATION, hereby enacts this by-law to re real the following by-laws:
