Bylaw No. 5
a bylaw to provide for the regulation of traffic on Christian Ialand Indian Reserve, in the Province of Ontario
(a) No vehicle shall be operated at a rate of apeed in excess of 25 Kiles an hour within any residential area designated and marked as such by the council of the band.
(b)No vehicle shall be operated on any beach area within the Christian Ioland Indian heveroce Reserve where aubdivided lands are deaignated and marked thereon by the council of the band.
(c) No vohicle shall be parked overnight on road allownces, This shall be limited to commonly used roads within the Christian Island Indian Heserve.
(d)Any peraon who violates any of the provisions of the bylaw shall be liable on sumary conviction to a fine not exceeding ten dollars or imprieoneent for a term not axceeding seven days, or both fine and imprisonment, ce6646a
