DO HEREBY RESOLVE:

That the Beausoleil Band Council and enact Bylaw No. 5 which reads as follows;

"The Council of the Beausoleil Band of Indians at a meeting held in the Community Hall at Christian Island on July 4th, 1968 makes the following bylaw pursuant to paragraph (b) and (r) of section 80, of the Indian Act.

Bylaw No. 5

A bylaw to provide for the regulation of traffic on Christian Island Indian Reserve, in the Province of Ontario

- (a) No vehicle shall be operated at a rate of speed in excess of 25 Miles an hour within any residential area designated and marked as such by the council of the band.
- (b) No vehicle shall be operated on any beach area within the Christian Island Indian Reserve where subdivided lands are designated and marked thereon by the council of the band.
- (c) No vehicle shall be parked overnight on road allowances. This shall be limited to commonly used roads within the Christian Island Indian Reserve.
- (d) Any person who violates any of the provisions of the bylaw shall be liable on summary conviction to a fine not exceeding ten dollars or imprisonment for a term not exceeding seven days, or both fine and imprisonment, ~~as provided~~
