A By-Law to provide for the regulations of the activities of boys and girls on the Christian Island Reserve, actually or apparently under the age of 16 years.

- No boy or girl on the Christian Island Indian Reserve actually or apparently under 16 years of age, shall loiter any place within the Christian Island Indian Reserve after; 11:00 o'clock in the afternoon during school holidays and weekends; 10:00 o'clock in the afternoon during school days.
- (b) No boy or girl on the Christian Island Indian Reserve actually or apparently under 16 years of age, shall be in any place of entertainment, lane, by-way or common within the said reserve after the hour of 10:00 o'clock in the afternoon unless accompanied by his or her parent or an adult appointed by the parent to accompany such child.
- (c) A boy or girl on the Christian Island Indian Reserve found violating provisions of paragraphs (a) or (b) may be warned and conducted home by a police officer and if the warning is not regarded, or after the warning the boy or girl is again found disobeying said paragraphs (a) or (b), the parents of such boy or girl shall be directed to meet with the Police Committee appointed by the Council of the Beausoleil Band for the protection of the children.
