DO HEREBY RESOLVE: the following By-Law be approved by Indian Affairs Branch.

Chippewas of Georgina Island By-Law No. 6

At a meeting held on September 11, 1967, a by-law to establish a Recreation Committee for the Georgina Island and Snake Island Reserve under Section 80 & 81 of the Indian Act.

- 1. There is hereby established for the Chippewas of Georgina Island and Snake Island, a Recreation Committee which shall be responsible for the development of a programme of recreation for the Reserve in accordance with Regulations issued under the Department of Education Act.
- 2. The said Committee shall be known as the Georgina Island Recreation Committee.
- 3. The Georgina Island Recreation Committee shall be composed of at least seven members and not more than twelve, of whom at least two are members of the Council.
- 4. The term of office of the members of the Georgina Island Recreation Committee shall be for a term of 2 years consistent with the terms of office of the Council.
- 5. Duties of the Recreation Committee:
  - (1) The Committee shall conduct or encourage and assist the programme of recreation which will meet the needs and interest of the members of the Georgina Island Band. Such programme shall include the social, cultural and physical aspects of recreation as applied to each age group, both male and female.

DO HEREBY RESOLVE:

By-Law No. 6 continued .....

- (3) The Committee shall assist, encourage and provide advisory services on request to all groups, organizations or persons carrying on recreation activities on the Georgina Island Reserve.
- (4) The Committee shall at all times keep the members of the Georgina Island Band aware of the recreation opportunities which are available and will continually interpret to the public the total community programme of recreation.
- (5) The Committee shall be responsible for all policies, rules and regulations relating to the administration of the community programme of recreation which are conducted directly by that committee or its employees and it shall have the powers to adopt by-laws, rules and regulations pertaining to the proper conduct of such community programme of recreation.
- (6) The Georgina Island Recreation Committee may recommend to the Band Council the appointment of a properly trained and qualified Recreation Director. Such Recreation Director shall be employed full-time and shall be directly responsible to the Georgina Island Recreation Committee.
- (7) The Committee may appoint recreation workers either part-time or full-time and shall be responsible for assigning the duties and responsibilities of such employees. Where a Band Recreation Director is employed such appointments should be subject to his recommendations.

DO HEREBY RESOLVE:

By-Law No. 6 continued. . .

- (8) The Committee shall conduct and supervise organized public recreation activities and is authorized to work jointly with other community organizations to provide and establish, operate, conduct and maintain a supervised recreation system and to operate, improve and maintain property, both real and personal, for parks, playgrounds, recreation centres, and other recreation facilities and activities.
- (9) The Committee may solicit or receive any gifts or bequests of money or services or any donations to be applied to principal or income for either the temporary or permanent use for facilities, equipment, programme or other recreational required.
- (10) Annually, the Committee shall submit and interpret to the Council a budget for its approval and shall make to the Council full and complete annual and other reports as required.
- (11) In carrying out the provisions of this by-law, the Committee shall at all times be the agent of the Georgina Island Council and while acting bona fide within the limits of the authority of this by-law neither the Committee nor any member thereof shall incur any liability by reason of anything done or left undone by the Committee; provided however, that nothing in this paragraph contained shall authorize or empower the Committee to incur any debt, liability or obligation for which the Georgina Island Band shall become liable without having previously obtained the consent of the Council.
