DO HEREBY RESOLVE:

BEING A BY-LAW TO AUTHORIZE THE CARRYING ON OF A COMMUNITY PROGRAM OF RECREATION WITHIN THE MEANING OF THE REGULATIONS UNDER THE DEPARTMENT OF EDUCATION.ACT.

- 1. THAT COURCIL OF THE BAND ENACTS AS FOLLOWS:
 - (a) PURLUANT TO REGULATION 19/66 MADE UNDER THE DEPARTMENT OF EDUCATION ACT, A COMMUNITY PROGRAM OF RECREATION IS HEREBY ESTABLISHED FOR THE RESIDEM'S OF THE RESERVE.
 - (b) THE SAID COMMUNITY PROGRAM OF RECREATION SHALL BE DIRECTED, MANAGED AND COMPROLLED ON BEHALF OF THE COUNCIL BY A COMMITTEE KNOWN AS THE BIG ISLAND RECREATION CONSTITUEE.
- 2. THE COMMITTEE SHALL LE APPOINTED FROM TIME TO TIME BY THE COUNCIL AS FOLLOWS:
