DO HEREBY RESOLVE: DÉCIDE, PAR LES PRÉSENTES:

SETON LAKE BAND OF INDIANS BY-LAW 141190-1

Being a by-law to provide the regulation of Disorderly Conduct and Nuisance.

WHEREAS paragraphs (d) and (r) of Section 81 of the Indian Act empowers the council of a Band to make by-laws respecting the regulation of Disorderly Conduct and Nuisance and the imposition of a penalty for the violation thereof;

AND WHEREAS the said council deems it expedient and in the best interest, and safety and welfare of the inhabitants of the SETON LAKE RESERVE.

NOW THEREFORE the council of the SETON LAKE band of Indians enacts a by-law thereof the following:

- In this by-law
 - (a) "Council" means the Council, as defined in the Indian Act, of the SETON LAKE band of Indians.
 - (b) "dwelling house" means the whole or any part of a building or structure that is kept or occupied as a permanent or temporary resident, and includes:
 - (i) a building within the curtilage of a dwelling house that is connected to it by a doorway or by a coverage and enclosed passageway and
 - (ii) a unit that is designed to be mobile and to be used as a permanent or temporary resident and that is being used as such a residence.
 - (c) "public place" includes any place to which the public have access as of right or by invitation, express or implied.
 - (d) "property" means real and personal property of every description and deeds and instruments relating to or evidencing the title or right to property.
- 2. No person shall cause a disturbance in or near a public place
 - (a) by fighting, screaming, shouting, swearing, singing or using insulting or obscene language
 - (b) by being drunk, or
 - (c) by impeding or molesting other persons.
- 3. No person shall disturb the peace and quiet of the occupants of a dwelling house by discharging firearms or by any other disorderly conduct in a public place.
