THEREFORE BE IT RESOLVED: that commencing, as of this date, speed restrictions regarding the Five Mile Point Reserve #3 roads will be restricted to 20mph, or 30kph, and,

THEREFORE BE IT FURTHER RESOLVED: that the above restriction will be applicable to any motor vehicle defined under the Motor Vehicle Act of British Columbia.
