BAND COUNCIL BY-LAW NO.5

## A By-law of the Nazko Indian Band for the Purpose of Establishing a Recreation Commission

The Council of Nazko Indian Bandy in open meeting assembled, enacts as follows:

- 1. There is hereby established a Commission known as the "Nazko-Kluskus Recreation Commission" (hereinafter referred to as the "Recreation Commission").
- The Recreation Co mission shall be composed of six (6)
- members who shall be appointed by Council as follows:
   One member each from the Council, the Community Development Program, and the Education Committee
- Three members to be appointed from the district at large. For the initial term, 3 members of the Recreation Commission shall hold office for a term of two years and three members shall hold office for a term of one year.
- c. The members appointed under the provisions of section 2 (1) (a) of this bylaw shall terminate automatic ally their term when their affiliation with the respective public bodies ends.
- The Recreation Commission shall elect from its membership a Chairman and such other officers needed to conduct business, and may adopt rules and resulations governing its procedure, provided that such rules and regulations do not contravene any Band by-laws.
- The duties and powers of the Recreation Commission shall be as follows The Recreation Commission may appoint, subject to the approval of the Council, recreation personnel for whom funds have been allotted or acquired, and when such recreation personnel for are to be paid from funds resulting from contributions from the grant-in-aid of the Community ecreation Branch consultation shall be held with the
