DO HEREBY RESOLVE:

WHEREAS the Musqueam By-Laws' Committee has submitted a Traffic By-Law and a Dog Regulations By-Law to the Musqueam Chief and Council.

AND WHEREAS the Chief and Council have accepted the By-Laws by a Council Motion, May 25, 1969, (operative under Sec. 80 - B and 80 - E respectively).

BE IT HEREBY RESOLVED THAT the Minister of Indian Affairs approve the following By-Laws:-

(1) The Council of the Musqueam Band of Indians at a meeting held May 6, 1969 - Band Office, makes the following bylaw pursuant to paragraph (b) and (r) of section 80 of The Indian Act.

Bylaw No. #001

A bylaw to provide for the regulation of traffic in Musqueam #2 Indian Reserve, in the Province of British Columbia.

- (a) No vehicle shall be operated at a rate of speed in excess of twenty (20) miles an hour within any residential area designated and marked as such by the council of the band.
- (b) No vehicle shall be operated over any bridge within the Musqueam Indian Reserve at a rate of speed in excess of the speed designated and marked thereon by the council of the band.
- (c) Any person who violates any of the provisions of this bylaw shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding ten dollars or imprisonment for a term not exceeding seven days, or both fine and imprisonment.
