BEING A BY LAW TO PROVIDE FOR THE REGULATION OF THE ACTIVITIES OF BOYS AND GIRLS ACTUALLY OR APPARENTLY UNDER 16 YEARS OF AGE.

WHEREAS PARAGRAPHS (c), (d), AND (r) OF SECTION 81 OF THE INDIANS ACT EMPOWERS THE COUNCIL OF A BAND TO MAKE BY LAWS RESPECTING THE REGULATION OF DISORDERLY CONDUCT AND NUISANCES AND THE IMPOSITION OF A PENALTY FOR THE VIOLATION THEREOF:

AND WHEREAS IT IS DEEMED TO BE EXPEDIENT TO LIMIT THE ACTIVITIES OF CHILDREN FOR THE WELFARE OF THE INHABITANTS OF THE KLUACHON LAKE RESERVE.

NOW THEREFORE THE COUNCIL OF THE ISKUT BAND OF INDIANS ENACTS AS A BY LAW THEREOF THE FOLLOWING:

- 1). NO BOY OR GIEL ON THE KLUACHON LAKE I.R. #1 ACTUALLY OR APPARENTLY UNDER 16 YEARS OF AGE, SHALL LOITER ANY PLACE WITHIN THE KLUACHON LAKE I.R. #1 AFTER NINE O'CLOCK IN THE AFTERNOON DURING THOSE MONTHS IN WHICH SCHOOL IS IN SESSION, AND ELEVEN O'CLOCK IN THE AFTERNOON DURING THOSE MONTHS IN WHICH SCHOOL IS NOT IN SESSION.
- 2). NO BOY OR GIRL ON THE KLUACHON LAKE I.R. #1 ACTUALLY OR APPARENTLY UNDER 16 YEARS OF AGE, SHALL BE IN ANY PLACE OF ENTERTAINMENT, STREET, LANE, BY WAY, OR COMMON WITHIN THE SAID RESERVE AFTER THE HOURS STIPULATED IN (1) ABOVE, UNLESS ACCOMPANIED BY HIS OR HER PARENT OR AN ADULT APPOINTED BY A PARENT TO ACCOMPANY SUCH CHILD, UNLESS FOR SOME UNAVIODABLE CAUSE.
- 3). ANY CHILD SO FOUND AFTER THE TIMES HEREBY APPOINTED SHALL BE WARNED BY ANY CONSTABLE, POLICE OFFICER, OR OTHER AUTHORIZED OFFICER TO DO SO, TO GO DIRECTLY HOME, AND IF SUCH CHILD REFUSES TO OBEY SUCH WARNING, OR IF AFTER SUCH WARNING THE CHILD IS FOUND LOITERING ON THE STREET OR IN PUBLIC PLACES, IT SHALL BE THE DUTY OF SUCH OFFICER TO TAKE THE CHILD HOME.
- 4). NO PARENT OR GUARDIAN SHALL PERMIT ANY CHILD TO BE ON THE STREET OR IN PUBLIC PLACES CONTRARY TO THE PROVISIONS OF THIS BY LAW.
- 5). ANY PARENT OR GUARDIAN GUILTY OF AN INFRACTION OF THE PROVISIONS OF THIS BY LAW SHALL BE LIABLE ON SUMMARY CONVICTION TO A FINE NOT EXCEEDING TWENTY FIVE DOLLARS
