

HEILTSUK BAND BY-LAW 18, 1983

This is Exhibit "A" to the Affidavit of Steve Saklas, 27<sup>th</sup> day of September, 1983. *Steve Saklas*

Being a by-law to amend by-law No.8 being a by-law regarding the regulation of traffic in Bella Bella Indian Reserve #1.

WHEREAS the Council of the Heiltsuk Band of Indians passed its by-law No. 8 on June 7, 1958 to regulate traffic in Bella Bella;

AND WHEREAS the Council of the Heiltsuk Band of Indians wishes to amend the said by-law;

NOWHEREFORE the Council of the Heiltsuk Band of Indians makes as a by-law thereof the following:

- 1. By-law No 8, dated June 7, 1958, respecting regulation of traffic is hereby amended by deleting section (a) thereof and substituting the following as Section (a);

"No vehicles shall be operated at a rate of speed in excess of 25 kilometres per hour on any road or wharf approach or field or any surface used as a road by vehicles within Bella Bella Indian Reserve #1;"

- 2. And by deleting section (c) thereof and substituting the following as section (c);

"Any person who violates any of the provisions of this by-law shall be guilty of an offense and shall be liable on summary conviction to a fine of one hundred dollars (\$100.00) or imprisonment for a term not exceeding 30 days, or both fine and imprisonment."
