THE BELLA BELLA BAND COUNCIL BY-LAWS By-Law no. 14.76

Being a by-law to amend by-law no. 5 to regulate the time or times during each day during which children shall not be on the streets without proper guardianship, and the _ge or apparent age under which they shall be required to be in their homes at the hour appointed.

WHEREAS paragraph (c), (d), (q), and (r), of section 81 of the Indian Act empower the Council of a Band to make by-laws respecting the observances of Law and Order, the prevention of disorderly conduct, and the imposition of a penalty for the violation thereof:

AND WHEREAS it is deemed expedient to regulate the activities of the children for the general welfare of the inhabitants of the Bella Bella no. 1 Indian Reserve. AND WHEREAS the Council of the Bella Bella no. 1 Indian Reserve deem it desirable to amend by-law no. 5.

NOW THEREFORE the Council of the Bella Bella no. 1 Indian Reserve enacts as a by-law thereof the following:

- In this by-lay,
- (1) "COUNCIL" means the Council, as defined in the Indian Act, of the Bella Bella Band of Indians.
- (b) "RESERVE" means the tract of land set apart by Her Majesty within the definition of the Indian Act, for the use and benefit of the Bella Bella Band Of Indians known as Bella Bella no. 1 Indian Reserve.
- (c) "CHILD" means any boy or girl actually or apparently under sixteen (16) years of age.
- (d) "NIGHT" means the daily period of time from nine o'clock in the afternoon to six o'clock in the morning during the months of September through June inclusive; and the daily period of time from ten-thirty in the afternoon to six o'clock in the morning during the months of July and August.
- 2. No boy or girl on the Bella Bella no. 1 Indian Reserve actually or apparently under sixteen (16) years of age, shall loiter any place within Bella Bella no. 1 Indian Reserve after nine o'clock in the afternoon.

No boy or girl on the Bella Bella no. I Indian Reserve actually or apparently under sixteen (16) years of age, shall be in any place of entertainment, street, lane, by-way or common within the said reserve after the hour of nine o'clock in the afternoon of Sundays to Thursday inclusive and after the hour of ten-thirty in the afternoon of Fridays, Saturdays and days preceeding holidays, unless accompanied by his or her parent or an adult appointed by a parent to accompany such child.

- 4. A boy or girl on the Bella Bella no. 1 Indian Reserve found violating the provisions of paragraph (2) or (3) may be warned (3 times) and conducted home by a police officer, and if the warning is not regarded or after the warning the boy or girl is again found disobeying said paragraph (2) or (3) the parents or guardian of such boy or girl will be warned and served a notice of warning after a third offense of his child.
- 5. Any parent of guardian shall be summoned for permitting his child habitually to eak said by-law, after having being warned in writing and shall be liable on summary conviction to a fine of \$25.00
