





REPEALING BY-LAW

WHEREAS the Council of the Swan Lake Band of Indians did enact By-law Number 1 effecting rules and regulations governing employee services on May 22, 1969 pursuant to Section 81 of the Indian Act.

AND

WHEREAS the Swan Lake Band Council is of the opinion that the said By-law is ineffective and is not required at this time.

NOW THEREFORE, the Council of the Swan Lake Band of Indians enacts as a by-law thereof the following.

By-law number 1-R-77 enacted and being a by-law to repeal by-law Number 1 effecting rules and regulations governing Band employees services for the Swan Lake Band enacted on May 22, 1969 is hereby approved and passed at a duly convened meeting of the Council of the Swan Lake Band of Indians this 22nd day of August, 1977.
