DO HEREBY RESOLVE:
DÉCIDE, PAR LES PRÉSENTES:

WHEREAS the Norway House Indian Band Council considers it necessary to, provide, by by-law pursuant to Section 85.1 of the Indian Act, for regulating the presence and use of intoxicants on the reserve of the Norway House Indian Band;

NOW THEREFORE IT IS ENACTED THAT:
DEFINITIONS

1. IN THIS BY-LAW,

- (a) "Band" means the Norway House Indian Band.
- (b) "Reserve" means the Reserve or all of the Reserves set aside from time to time for the use and benefit of the Band.
- (c) "Band Member" means a member of the Band.
- (d) "Intoxicant" means any intoxicating substance which is capable of human consumption and contains either more than 1% by weight or more than 1% by volume of any alcohol or alcohols.

PROHIBITIONS

2. (a) Every person who sells, barters or manufactures any intoxicants on the reserve is guilty of an offense punishable on summary conviction.
