WE HEREBY RESOLVE:

WHEREAS the Moose Lake Indian Band Council considers it necessary to, provide, by-law pursuant to Section 85.1 of the Indian Act, for regulating the presence and use of intoxicants on the reserve of the Moose Lake Indian Band;

NOW THEREFORE IT IS ENACTED THAT:

DEFINITIONS:

- IN THIS BY-LAW
  - (a) "Band" means the Moose Lake Indian Band
  - (b) "Reserve" means the Reserve or all of the Reserves set aside from time to time for the use and benefit of the Band.
  - (c) "Band Member" means a member of the Band.
  - (d) "Intoxicant" means any intoxicating substance as defined in the Indian Act.

PROHIBITIONS

- (a) Every person who sells, barter or manufactures any intoxicants on the reserve is guilty of an offence punishable on summary conviction.

WHEREBY RESOLVE / ÉCIDE, PAR LES PRÉSENTES:

- 2 (b) Every person who possesses, or supplies to another person, any intoxicant on the reserve is guilty of an offense punishable on summary conviction.
- (c) Every person who is intoxicated on the reserve is guilty of an offense and punishable on summary conviction.
- (d) Every person who intends to transport any intoxicating substance on the Reserve is guilty of an offense punishable on summary conviction as per by-law pursuant to section 85.1 of the Indian Act.





EXCEPTIONS

Notwithstanding anything, in this by-law, no person commits an offense under this by-law the possession, or by the supply to another person, of an intoxicant.

- (a) By the possession, or by the supply to another person, of an intoxicant which was manufactured for medicinal purposes, is in a container, labelled so as to indicate that it is for medicinal purposes only.
- (b) By the possession of any alcoholic beverage which they can establish was for their own consumption upon the direction or recommendation of a physician.

The making of this by-law was assented to by a majority of the electors of the Band who voted at a special meeting of the Band called by the members of the Band of Moose Lake for the purpose of considering the By-law.
