BY-LAW NUMBER
BEING A BY-LAW TO REPEAL AND REPLACE ALL

PRIOR BY-LAWS PROHIBITING INTOXICANTS.

AND WHEREAS the ARRIOS Indian Band considers it desirous to undertake measures for the protection of the community;

AND WHEREAS the Council of the Band is desirous of declaring in effect a prohibition against the sale, barter, supply or manufacture of intoxicants on the reserve of the band; against any person being intoxicated on reserve; and against any person having intoxicants in his possession on the reserve; and wish to provide for an exception thereto;

AND WHEREAS Subsection 85.1(1) of the <u>Indian Act</u>, authorizes the council of a band to make by-laws:

- (a) prohibiting the sale, barter, supply or manufacture of intoxicants on the reserve:
- (b) prohibiting any person from being intoxicated on the reserve;
- (e) prohibiting any person from having intoxicants in his possession on the reserve; and
- (d) providing for exceptions to any of the prohibitions established pursuant to paragraph (b) or (c);

AND WHEREAS subsection 85.1(4) of the Indian Act provides that every person who contravenes a by-law made under this section is guilty of an offence and is liable on summary conviction, in the case of a by-law made under paragraph 85.1(1)(a), to a fine of not more than one thousand dollars or to imprisonment for a term not exceeding six months or to both; and in the case of a bylaw made under paragraph 85.1(1)(b) or paragraph 85.1(1)(c), to a fine of not more than one hundred dollars or to imprisonment for a term not exceeding three months, or to both; and

AND WHEREAS a majority of the electors of the Band who attended a special meeting of the Band on ascust 3/1/2 called by the council of the Band on band on the Band on the band on the special meeting band on the special meeting band on the band on the special meeting band on the band on the band on the band of this bylaw, assented to the contents of this bylaw;

AND WHEREAS the Council of the Band did enact PRIOR BY LAWS PROBLETING
INTEXICANTS and wishes to repeal AND REPLACE ALL PRIOR
INTEXICANT BY LAWS WITH THIS BY LAW.

NOW THEREFORE, it is hereby enacted pursuant to section 85.1 of the Indian Act:

## Short Title

LATUR ORANG

1. This by-law may be cited as the <u>RAGID 5</u> Indian Band Intoxicant By-law.

## Interpretation

2. In this Bylaw:

"Band" means the RAPIOS Indian Band;

"Reserve" means all those lands defined as a "reserve" within the meaning of the Indian Act, R.S.C. 1985, c-I-5 and set apart for the use and benefit of the house Region. Band of Indians and known as Region. Indian Reserve number(s)

## **Prohibitions**

- 3. No person shall be intoxicated on the Reserve.
- 4. No person shall be in possession of an intoxicant on the Reserve.
- 5. No person shall sell, barter or supply an intoxicant to anyone or manufacture intoxicant on the Reserve.
