A By-Law to Regulate intoxicants on the reserve of the Little Grand Rapids:

Whereas, the Indian Act provides in subsection 85.1 (1) subject to subsection (2), the Council of the Band may make By-Law:

- (a) prohibiting the sale, barter, supply or manufacture of -intoxicants on the Reserve of the Band
 - (b) prohibiting any person from having intoxicants on the Reserve of the Band
 - (c) prohibiting any person from having intoxicants in his possession on the Reserve, and,
 - (d) providing for exception for any of the prohibitions established pursuant to paragraph (b) or (c).

Whereas, subsection 85.1 (2) of the Act provides a By-Law may not be made under this section unless it is first assented to by a majority of the electors of the Band who voted at the special meeting of the Band called by the Council of the Band for the purpose of considering the By-Law

Therefore, Be it resolved, the Council of the Little Grand Rapids Band of Indians enacts the following as their By-Law:

No person shall sell, barter, supply or manufacture intoxicants on the Reserve of the Little Grand Rapids Indian Band.

No person shall have any intoxicants on the Reserve
of the Little Grand Rapids Band,

No person shall have in his possession, any intoxicants on the Reserve of the Little Grand Rapids Band,

Assented to by a majority of the electors of the Band
who voted at a special meeting of the Band on
OCT, 25, 1989 called by the Band Council for the purpose
of considering these By-Laws.
