DO HEREBY RESOLVE:  
 DÉCIDE, PAR LES PRÉSENTES:

WHEREAS, pursuant to Section 85.1 of the Indian Act, the Council of the Garden Hill Band has authority to make by-laws respecting the prohibition of intoxication on the reserve of the Band;  
 AND WHEREAS, the Council of the Garden Hill Indian Band considers it desirable and necessary for the regulation of the intoxication on the reserve of the Garden Hill Band;  
 NOW THEREFORE, the Council of the Band with advise and consent of a majority of the electors of the Garden Hill Indian Band enact as follows;

Definitions:

1. In this by-law,
  - a) " Band " means the Garden Hill Band,
  - b) " Council of the Band " means the Chief and Councillors chosen for the good government of the Band under Section 74 of the Indian Act or according to the custom of the Band;
  - c) " Reserve " means all the land, the legal title to which is vested in her Majesty, that has been apart by her Majesty for the use and benefit of the Garden Hill Indian Band, and includes any special Reserve;
  - d) " Intoxicants " means any substance which is an intoxicant within the definition of " intoxicants " for the purpose of the Indian Act.

Prohibitions:

- Any person who is intoxicated on the reserve is guilty of an offence and is liable in summary conviction to a fine of not more than one hundred dollars or to imprisonment for a term not exceeding three months or to both fine and imprisonment.

Assented to by a majority of the electors of the Band who voted at a special meeting of the Band on September 20, 1985 called by the Band Council for the purpose of considering this by-law.
