The Council of the Red Pheasant Band of Indians at a meeting held at the Red Pheasant Band Office makes the following by-law pursuant to clause (r) section 81 of the Indian Act.

By-law No. 9

(a) No person shall destroy, cut or tear down and fence, corral within the boundaries of the Red Pheasant Reserve, unless sanctioned to by the Red Pheasant Band Council.

The imposition on summary conviction of a fine not exceeding one hundred dollars or imprisonment for a term not exceeding thirty days, or both, for violation of a by-law made under this section.
