DO HEREBY RESOLVE:

THAT the following regulation of traffic be applicable throughout Poundmaker Reserve.

BY-LAW No. 1

- (a) No vehicle shall be operated at a rate of speed in excess of thirty-five miles an hour within the designated reserve.
- (b) No vehicle shall be operated at a rate of speed in excess of fifteen miles an hour within the school zones of the Poundmaker Reserves No. 114 designated and marked as such by the council of the Band.
- (c) Notwithstanding above sub-sections (a) and (b) the Band Council may in the public interest fix a maximum speed on the reserve roads or portions thereof and shall cause to be erected at each end of the reserve roads or portions thereof, and at intervals along the roadways or portions thereof, signs indicating such maximum speeds. No person shall drive a motor vehicle on such roadways or portions thereof, upon which such signs have been erected at a speed greater than that so dedicated.
- (d) That any vehicle left on or near any of the said roadways on Poundmaker Reserve shall be removed within forty-eight hours, this removal to be the sole responsibility of the owner of such a vehicle. Failure to do so will result in action taken against the person responsible and charges assessed accordingly.
- (e) Any person who violates any of the provisions of this by-law shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding one hundred dollars or imprisonment for a term not exceeding thirty days, or both fine and imprisonment.
