THEREFORE, be it resolved that the Councils have declared that the following law applies to any class of business, trade or calling carried in or on the Territory of Doncaster No. 17 in the Province of Quebec (hereinafter referred to as the Territory).						
1. For the purposes of this law the following definitions shall apply:						
"Commercial Venture" means any class of business, trade or calling						
"Peace Officer"means a Peacekeeper, Conservation Officer or any person authorized by the Councils to carry out law enforcement functions on the Territory.						
" <u>Justice</u> " means a Justice of the Court of Kahnawake.						
 No person may conduct or carry on a commercial venture on the Territory. 						
3. Any person who contravenes Section 2 is guilty of an offence and shall be liable on summary conviction to a fine not exceeding One Thousand Dollars (1,000.00) or to imprisonment not exceeding Six (6) months, or both.						
4. Any peace officer may lay a complaint under Section 2 before a Justice.
