To enact a bylaw providing for the preservation, protection, and management of Oyster Fisheries along the shores of the Middle River Indian Reserve #1, under section 81 sub-section 0 of the Indian Act, R. S. C., Chapter 1-6.

That the residents of the Middle River Indian Reserve shall use SCUBA equipment for the preservation, protection, and management of the Oyster Fisheries in and along the shores of the Middle River Indian Reserve #1 and any other area of water leased out by any of the Band members or by the Micmac Fisheries Development Association.
