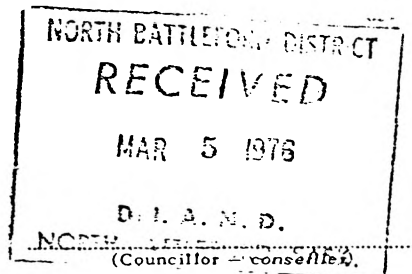
This By Law shall come into force and effect on the date of final passing by Council.
