DO HEREBY RESOLVE:
BYLAU NO. 2

A By-Law to establish a Curfew.

That permission be granted to the Chief and Council of the Keeseekoose Band to establish a Curfew Bylaw for the Keeseekoose Indian Meserve. This action is being taken in conjunction with the Special Constable presently employed on the Keeseekoose Indian Reserve.

- 1. No child under the age of 15 years, within the Keeseekoose Meserve, shall be out after the hour of 9:00 O'clock, P.H., and every such child shall be in his or her home after that hour; This applies to the villages and the entire Reserve; Provided that nothing herein contained shall apply to a child who is under proper control or guardianship or is out for some unavoidable reason.
- 2. The person appointed by the Council to do so shall ring a bell at the hour of 9:00 O'clock, P.M., as a warning that the provisions of this bylaw must be complied with, which bell shall be called the "curfew bell".
- 3. Any child so found after the time appointed shall be liable to be warned by any constable or peace officer to go home and if after such warning the child is found loitering, he or she may be taken by such constable or peace officer to his or her home; and
- 4. Any parent or guardian found guilty of permitting a child to contravene the provision of this by-law, after being warned in writing by the Band Secretary, shall be liable to penalties provided under Section 60, sub-paragraph (r) of the Indian Act as follows:

The imposition on summary conviction of a fine not exceeding \$100.00(dollars) or imprisonment for a term not exceeding 30 days or both fine and imprisonment for violation of a bylaw made under this section.
