WHEREAS the Council of the Fort Folly Band did enact By-Law No. 002 on the 26th day of January 1999, pursuant to paragraphs 81 (g) of the Indian Act;

AND WHEREAS the said Council is of the opinion that such a by-law is not required at this time;

NOW THEREFORE the Council of the Fort Folly Band enacts as a by-law thereof the following:

1. By-Law No. 002 enacted on the 26th day of January, 1999, and being a By-law Zoning on the Reserve be and the same is hereby repealed.
