By-Law No 1999.01 PREVENTION OF DISORDERLY CONDUCT AND NUISANCES

WHEREAS section 81, paragraph (d),(q) and (r) of the Indian Act empower the Council of a Band of Indians to pass by-laws to provide the prevention of disorderly conduct and nulsances, matters arising out of or ancillary to the exercise of powers under this section, and the imposition of a penalty for the violation of any such by-law;

WHEREAS the Council of the Fort Folly Band did enact By-Law No. 1999.01 on the 28th day of June 1999, pursuant to paragraphs 81 (d), (q) and (r) of the Indian Act;

AND WHEREAS the said Council is of the opinion that such a by-law is not required at this time;

NOW THEREFORE the Council of the Fort Folly Band enacts as a by-law thereof the following:

 By-Law No. 1999.01 enacted on the 28th day of June, 1999, and being a By-law Prevention of Disorderly Conduct and Nuisances on the Reserve be and the same is hereby repealed.
